Under MAP-21 and through the Infrastructure Investment and Jobs Act (IIJA) Congress established national goals for the Federal-aid highway program. These goals resulted in rulemakings that would support transportation decision making through a focus on performance on the National Highway System (NHS). In 2016, the Federal Highway Administration issued rulemakings that required State Departments of Transportation to set and meet Performance Targets.

The memorandum and its enclosures serve to update Memorandum 2019-3, which pertains to the scheduling, notification, adoption, and reporting of the above-mentioned Performance Targets. PERFORMANCE MEASURES

Performance Management is a federal requirement that originated with the MAP-21 and carried on to current legislation. In 2016, the Federal Highway Administration issued rulemakings that require State Departments of Transportation to set and meet Performance Targets. MPOs are given the choice to support their state's performance targets or develop their own performance targets. There are currently five categories of performance targets; a sixth is on the way. More information is available: https://www.fhwa.dot.gov/tpm/.

MPOs have four requirements related to Performance Measures. First, they will adopt a resolution for each category (PM1, PM2, etc.). They can create separate resolutions, or they can adopt the combined resolution. Second, they will adopt an agreement laying out the MPO's roles and responsibilities. Third, they will develop a *System Performance Report* for the LRTP and a *TIP Write-up* for the TIP. Finally, they will include projects in the TIP that support the performance targets. For example, guardrail projects will satisfy PM1 requirements and a resurfacing project will satisfy PM2 requirements.

Timeline

PM1 – Safety Targets

Provide to MPOs around August of every year Receive resolution 180 days after send-out

PM2 - Bridge and Pavement Targets

Provide to MPOs around August of 2022, 2024 Receive resolution 180 days after send-out

PM3 – Congestion / Air Quality Measures
Provide to MPOs around August of 2022, 2024
Receive resolution 180 days after send-out

Transit Asset Management

Provide to MPOs only if TAM is adjusted Receive resolution 180 days after send-out

Transit Safety

Transit Providers will provide info to MPOs Receive resolution 180 days after send-out

Master List

Provide to MPOs around August of every year

2024 – Provide Greenhouse Targets to MPOs 2024 – Provide Blank Agreement to MPOs As Needed – Provide PM1 Methodology As Needed – Help MPOs with TIP Write-up As Needed – Help MPOs with System Perf Rep.
