Please find the attached letter from Mr. Eric Christie, State Maintenance Engineer. Included is a schedule for the 2023 Bridge Inspection Compliance Reviews and all other 2023 bridge maintenance related training.

Please note that if you received this memo, your county or municipality is scheduled for a 2023 Bridge Inspection Compliance Review (See attached schedule). All local agency bridge owners are required to comply with the National Bridge Inspection Standards (NBIS) outlined in CFR 650.305 Subpart C. ALDOT conducts the Bridge Inspection Compliance Reviews to ensure that all local agencies are complying with the NBIS requirements.

The 2023 bridge inspection compliance reviews will include all the local agency bridge owners in the following ALDOT Areas:

- Alex City Area
- Tuscaloosa Area
- Montgomery Area
- Fayette Area

Each local agency bridge owner in the above referenced ALDOT Areas are required to do the following:

- Attend the ALDOT area review meeting (see attached schedule)
- Submit a Bridge Inspection Program Questionnaire (see attached link)

In addition to the ALDOT area review meeting, a select few local agencies will also be required to have a bridge inspection file review (see attached schedule). These file reviews will take place in the local agency's office where the bridge files are located.

ALDOT will also host several bridge maintenance related training courses throughout the year. These courses are free for any employee of a local agency bridge owner or any individual under contract to a local agency to provide services related to the course topic. Sign-up for these courses are on a first-come first-serve basis.

2023 Bridge Maintenance Related Training includes:

- Bridge Inspection Refresher Training (Two Day School)
- Element Inspection / BrM User Training (Two Day School)
- Countermeasure Design for Bridge Scout & Stream Instability
- Fracture Crtical Inspection Techniques for Steel Bridges
- Safety Inspection of In-Service Bridges

Bridge Inspection Program Compliance Review

The State of Alabama's bridge inspection program is a federal compliance program administered by FHWA. To comply with FHWA Guidelines to review the bridge inspection procedures for all public bridge owners, ALDOT has agreed with FHWA to inspect each ALDOT area once every three years. Furthermore, each local government entity is required to attend the area review so that they more fully understand the acceptable standard for a bridge inspection program in the state of Alabama. An intregal part of the review process is that each governmental entity is required to complete a Bridge Inspection Program Review Questionnaire. When a review is conducted at an Area office, each County and Municipality that owns bridges and is located within the geographic limits of that area is required to attend the Area review and bring an updated and completed Bridge Inspection Program Questionnaire with them. Counties and Municipalities that are scheduled for their own reviews are still required to attend the Area review.

The prerequisite course is FHWA-NHI-130101—Introduction to Safety Inspection of In-Service Bridges, a 14-hour web-based training and assessment. This course can be found on NHI's website. Element Inspection & BrM User Training

In January of 2015, ALDOT's Maintenance Bureau went live with a new bridge inspection database, ALDOT BrM. At that time, the Maintenance Bureau also began requiring all NBI Inspections to include an Element-Level Inspection. In preparation for these changes, this office hosted Element-Level Inspection classes in 2013 and BrM User Training classes in 2014. Both classes were mandatory for anyone wishing to obtain or keep an active Alabama CBI status. These classes have now been combined into one class, and all inspectors are expected to have attended this class or both of the previous classes. If you have not yet attended, or would like a refresher, the course is being offered again this year on the following date:

Bridge Inspection Refresher Training

This office conducts multiple sessions of this training throughout the state. Participants associated in any facet of the state's bridge inspection program are highly encouraged to attend.

Participants may attend any session they desire, and pre-registration is not required. If a certified bridge inspector in the State of Alabama did not attend one of the Bridge Inspection Refresher Training sessions last year, it is mandatory that they attend one of the sessions this year to remain in active status.

These training sessions will include recent changes in bridge inspection procedures, forms, documentation, bridge management, scour, underwater inspections, bridge ratings, and other pertinent topics.
