IN THE EVENT THAT PERMIT CRITERIA ARE NOT MET OR A PERMIT IS NOT REQUIRED, THE APPLICANT WILL SUBMIT A BEST MANAGEMENT PLAN (BMP) DESIGNED TO MANAGE AND MINIMIZE THE DISCHARGE OF REGULATED POLLUTANTS INTO THE ENVIRONMENT.

THE APPLICANT SHALL INDEMNIFY AND SAVE HARMLESS ALDOT FROM ALL SUITS, ACTIONS OR CLAIMS OF ANY CHARACTER BROUGHT BECAUSE OF INJURIES OR DAMAGES RECEIVED BY ANY PERSON(S) OR PROPERTY OR BECAUSE OF LACK OF COMPLIANCE WITH APPLICABLE LAWS OR REGULATIONS DUE TO ACTION OR INACTION ON THE PART OF THE APPLICANT. SUITS, ACTIONS AND CLAIMS INCLUDE THOSE BROUGHT BY PRIVATE OR PUBLIC ENTITIES AND MAY BE CIVIL OR REGULATORY IN NATURE.
