I. Study Introduction

- a. Scope of Work: The purpose of this study is to evaluate each of Alabama's Welcome Centers and Rest Areas for compliance with accessibility standards as defined by the Americans with Disabilities Act. Evaluation of structural, mechanical, electrical, plumbing and fire protection systems along with a review of applicable building codes has not been conducted as part of this study's scope. This study identifies ADA non-compliant items for each location and describes minimum corrections required to attain compliance. The findings presented in this study are intended to be used as a budgetary baseline by ALDOT to aid in determination of whether renovation or replacement of each facility is practical. Before beginning any building renovation, a full code review and building assessment should be performed. Detailed design of any recommended improvements for each location, either through renovation or new construction, is not included in this study. It should be noted that the corrections identified in this assessment relate only to ADA Compliance and do not address aesthetic and functional deficiencies which may also be a factor in prioritizing Welcome Center and Rest Area improvements.
- b. This study has been limited to the evaluation of each facility's compliance with current ADA Design Standards as outlined in the 2010 ADA Standards for Accessible Design¹ and ADA Safe Harbor Provisions² as applicable to each site evaluated. The 2010 ADA regulations include a concept called "safe harbor" that allows existing elements in facilities constructed before 3/15/2012 and that fully comply with the 1991 ADA Standards to remain in place until those elements are altered. The exception applies to elements that might otherwise have to be modified under 1) the program access requirements for public entities, 2) the readily achievable barrier removal requirements for places of public accommodation, or 3) the path of travel requirement for any alteration that affects the usability of a primary function area in any covered facility. Any building element found in non-compliance and requiring replacement will be required to meet the 2010 ADA regulations.
- c. The Site Evaluation Checklist (see Region Report Appendices) created for this study is based upon the 2010 ADA Standards for Accessible Design. Diagrams and checklist format is based upon the ADA Checklist for Existing Facilities as produced by the Institute for Human Centered Design and the ADA National Network.
- d. Evaluations for this study were limited to ADA Priorities 1-4, which address the program requirements included at public welcome centers and rest areas. Additional ADA Recreational Checklists were not utilized, as those amenities are not provided at the facilities included in this study. If a location included a public attraction (i.e. De Soto Trail, historical information, Blue Star Sign, etc.) then evaluation of access to these attractions was included.

e. ADA Priorities included in this evaluation:

- Priority 1- Approach & Entrance Priority 2- Access to Goods & Services Priority 3- Toilet Rooms Priority 4- Additional Access
- f. ALDOT Commitment Items: The items listed below were included as long term goals to be implemented by December 2009 as outlined in ALDOT's 2008 ADA Transition Plan:
 - i. Striping and signage of parking areas
 - ii. Installation of signage and grab bars within rest rooms
 - iii. Provide TTY telephone
 - iv. Retreading stairways
 - v. Replacing inaccessible door handles
 - vi. Installation of automatic doors
 - vii. Curb ramps and cuts
 - viii. Accessible drinking fountains
 - ix. Accessible lavatories

g. Study Assumptions:

- i. **Introduction:** The evaluations for each location were limited to verifying ADA accessibility for public use at each facility, including site and interior building amenities. Service spaces accessed by only facility staff and not accessible to the public were not evaluated.
- ii. Facility Operation Practices: Standard operating practices of facility management were not considered during this evaluation. Several facility locations provide two toilet rooms per gender and operate by providing public access to one set of toilet rooms while locking and cleaning the other set. During times of peak demand, all toilet rooms may be opened for public access. This study makes the assumption that for facilities that currently provide only one accessible toilet room per gender, the accessible toilet stall must be available to the public at all times. If a patron requires use of the accessible toilet room while it is closed for cleaning, the attendant must immediately suspend cleaning and provide access. Further notification or standardization of this operating procedure may be required to educate staff personnel of operating requirements to meet accessibility needs at all times the facility is open to the public. If a facility provides multiple toilet rooms per gender, but only one toilet room per gender is considered accessible, then only the accessible toilet room was evaluated for ADA compliance.
- iii. **Site Evaluation:** The site features included in this evaluation were parking areas and access to buildings, vending, attractions and picnic tables.
 - 1. **Approach Roadway Signage:** To provide consistency across facilities, the 'International Symbol of Accessibility' sign should be installed on the approach roadway near the entrance to accessible facilities.

- 2. Parking Areas: Evaluation of parking areas included both car parking and truck/RV parking. Each site evaluated included separate lots for each and each lot was considered independently in determining the required number of accessible spaces. A separate Priority 1 Checklist was completed for each lot. At some sites, the number of designated accessible spaces exceeded the minimum number required. At these locations, budget estimates for providing compliant accessible parking are based on providing more than the minimum number required but in some cases less than the number currently designated as "accessible". The Priority 1 Checklist for "Truck Parking" addresses the truck/RV parking lot and the accessible route from the lot to the nearest building visitor entrance. The Priority 1 Checklist for "Car Parking" addresses the car parking lot and all other exterior accessible routes. For the purposes of this study it is assumed all reconstruction of parking areas will utilize concrete pavement. Concrete pavement was selected because of its durability, the strict grade controls required for accessible parking areas, and the highly variable cost of asphalt for the relatively small quantities required at each site.
- 3. Vending: Vending machines provided at each site were found to be "freestanding" and are thus not considered "fixed equipment". Because the machines are not fixed equipment they were not evaluated for ADA compliance. However, an accessible route and clear floor space must still be provided and these requirements were evaluated under Priority 1 "Exterior Accessible Route".
- 4. **Attractions:** Access to all attractions must be provided. Attractions include all signs/monuments which are accessible to the general public.
- 5. **Picnic Tables:** Priority 2 checklist 'At Dining Surfaces' was used to evaluate picnic tables at each facility. Where more than one accessible table was required and pavilions were provided at some tables, at least one accessible table will be provided under a pavilion.
- 6. Sanitary Dumping Stations: Each Rest Area/Welcome Center provides a sanitary dumping station. However, these facilities are not operable at four of the sites (WC3, WC5, WC6, RA3). Due to the expected low number of users to these facilities and the high cost of compliance modifications, this study assumes that signage will be placed at each dumping station that instructs users with disabilities on how to contact on-site staff for assistance. The addition of signage was determined to be the most cost effective way to provide accommodation.
- iv. **Building Evaluation:** The interior building features included in this evaluation were lobby and seating, tourism services, accessible toilet rooms, drinking fountains and telephones.
 - Lobby and Seating: This section included evaluation of the main building entrance and lobby area. If a facility provided separate building entrances from car parking and truck/RV parking both entrances were evaluated for accessibility.

- 2. **Tourism Services:** Access to the tourism service counter was evaluated under the Priority 2 Checklist. Where applicable, access to any tourism brochure stands or interior exhibits was evaluated.
- 3. **Toilet Rooms:** Access to a minimum of one accessible toilet stall, lavatory and required toilet room accessories per gender was evaluated.
- 4. **Drinking Fountains:** Access to one drinking fountain for ADA accessibility and for one drinking fountain for standing persons must be provided.
- 5. **Public Telephones:** If a location provides a telephone it must be accessible and provide a TTY touchpad and associated signage. At locations where public telephones have been removed; instruction has been provided to remove any empty phone booths and associated signage.


































































