RE:

Items of Work Requiring Samples/Test Reports/Certifications

For items of work that require samples/test reports/certifications, no payment shall be made until they have been received by the Department. This guidance also applies to stored materials as described in Article 109.07 of the Standard Specifications. ALDOT Form C-30 (attached) or a similar form shall be used to track the quantity for each pay item requiring test reports/certifications and the quantity installed.

For pay items that are on the Department's "List of Qualified Materials, Sources and Devices," the manufacturer shall provide back up as needed to verify they are on an approved list.

Under rare circumstances, the Region Engineer or State Construction Engineer may approve payments to Contractors without samples/test reports/certifications with the expectation that they are provided in a timely manner or the corresponding pay items are to be removed from future estimates.
