RE: Time Charges – No Charge Reasons **REVISED 4-30-2014** (see attached email)

C.I.M. 2-2001 is hereby voided.

Attached is a revised list of reasons for <u>not</u> charging time on construction projects. Project personnel should immediately begin using the revised list for their project diaries and *C-20 Progress Report*. For their convenience, the SiteManager database for *Credit Reasons* has also been updated with these revisions.

Please note that two of the reasons are shown in italics as **DON'T USE**. As outlined at the Construction & Materials Engineers' Conference in Huntsville earlier this month, specification and policy changes have rendered these reasons as invalid. However, they cannot be deleted from the SiteManager code table without causing errors with historical data. Hence, they are noted as **DON'T USE** to alert Project Managers to not use them and choose another reason. Please emphasize to your personnel.

In addition to the revised list, more explanations have been included in an effort to provide guidance to project managers on the intent of the reasons. Also, reasons in which remarks are needed to explain the cause of the no charge are marked with an "*" the same as in the *ALDOT SiteManager Policies and Procedure: DWR – Diary*. Based on reviews of project diaries in SiteManager, this is an area in which improvement is needed.

Subject: RE: CIM 1-2013 Time Charges REVISED

Attached is a revision of CIM 1-2013 to account for the email below and to add a new reason for Waiting on Local Acceptance. This reason is for city and county projects in which acceptance for maintenance requires concurrence by the mayor, city council, county commission, etc. after the final inspection. In most cases, the local project manager, especially when it is the county engineer, has authority to accept the project for maintenance. However, with the multitude of ATRIP projects and the usage of consultants for inspecting them, concurrence from the local governing body is being required before maintenance is assumed. In cases where the final inspection and all punch list work has been completed and there is no other applicable reason (such as Waiting on Vegetation Establishment), then 0 charge the day for Waiting on Local Acceptance.

Based on the previous emails, we have removed "Awaiting Final Acceptance" from the list of reasons. Due to programming issues in SiteManager, the reason will still appear in the table, but will continue to have "DON'T USE" in the wording.

The CIM will be updated on our website as well as the SiteManager DWR-Diary Policies & Procedures in the near future.

Subject: CIM 1-2013 Time Charges - No Charge Reasons UPDATE

As discussed at the CE/ME Quarterly Meeting in December, we have removed the wording "DON'T USE" from the no charge reason "Resurfacing Start-up Delay" in SiteManager based on the large volume of resurfacing work both ongoing and planned during the ATRIP program. This will give the Division/Region more flexibility to coordinate the work to be performed during the current paving system as we have done in the past. In lieu of revising and publishing another CIM, this email serves as temporary authorization to utilize the reason. We will revisit the issue at future CE/ME meetings once the ATRIP program begins to subside.
