
## ALDOT BUILD AMERICA, BUY AMERICA (BABA) REQUIREMENTS FLOWCHART



- 2. The cost of the components of the manufactured product that are mined, produced, or manufactured in the United States is greater than 55% of the total cost of all components of the manufactured product, unless another standard for determining the minimum amount of domestic content of the manufactured product has been established under applicable law or regulation.
